

BC Builds



BC Builds Vision

- BC Builds assists with finding creative opportunities to add housing on existing sites, and to incorporate housing above new community infrastructure. BC Builds can help secure a development partner and a building owner/operator.
- Grants of up to \$225,000 per unit to lower construction costs are available for buildings to be owned and operated by non-profits and First Nations development companies.

BC Builds Development Model

- BC Builds brings together landowners and residential developers to speed up project development timelines
- The goal of BC Builds is to move projects from concept to construction in 12-18 months, rather than the typical three-to-five years.
- A key component of the initiative is to leverage underused public lands (parking lots, on top of community centres/fire halls) to create more viable rental projects, along with grant money to keep rents more affordable and get projects off the ground.

RECOMMENDATION

THAT Council direct staff to re-engage a qualified arborist to re-assess the Oak Trees on Lillooet Avenue West; and

THAT Council authorize staff to follow the recommendations in the updated report from the qualified arborist immediately.

SUMMARY

To present Council with an updated staff report regarding the Oak Tree on Lillooet Avenue West.

BACKGROUND

On August 21, 2023, the CAO presented a Report to Council at a Special Closed meeting summarizing the issue with the limb that fell in July and the report from Urban Environment Ltd. At that meeting, the following motions were passed:

THAT due to a public safety concern for people and property, Council authorize staff to have all four oak trees on Lillooet Avenue removed; and

THAT Council authorize staff to fund the tree removals and replacements from reserves.

CARRIED SIC-2023-08-06

THAT staff be directed to research options including costing to make the oak tree removal area on Lillooet Avenue more aesthetically pleasing and report their findings back to Council; and

THAT staff be directed to work with the contractor during the removal of the oak trees to determine whether there is any salvageable wood that can be saved for possible use in a future beautification project of that same area.

CARRIED SIC-2023-08-07

Oak Trees on Lillooet June 25, 2024

THAT the motions made at the Special Closed Council Meeting of August 21, 2023 pertaining to item 6(a) – CUPE Negotiations and item 6(b) – Oak Tree Removal be released to the public.

CARRIED SIC-2023-08-08

Release from Closed resolutions were to be received for information at the September 11, 2023 Regular Council meeting, however, they were inadvertently not included. That meeting was cancelled by Mayor Wood on September 8, 2023.

Shortly before the October 3, 2023 Regular Council meeting, Mayor Wood requested that the Closed Meeting resolutions relating to the trees be reported out at the meeting. The CAO planned to do so verbally, however, the meeting collapsed and subsequently, the tree resolutions were not discussed at that meeting.

On October 11, 2023 the Corporate Officer received an email with a Notice of Motion from Councillor Allen stating the following:

Notice of Motion from Councillor Allen, re Four Oak Trees:

Whereas the last surviving oak trees on West Lillooet Avenue are an important part of the Village streetscape and

Whereas they have historic and cultural value, beyond their environmental value and Whereas our Urban Forest Management Plan calls for the retention and maintenance of mature trees and

Whereas council has not yet seen the arborist report concerning these trees

Be it resolved that that staff be instructed to take no further action concerning these four oak trees until council has had an opportunity to review the arborist report and explore preservation options for them.

I received an email later that day from Mayor Wood requesting that Councillor Allen's motion be added under New Business at the next Regular Council Meeting.

On October 16/18, 2023 the CAO presented a Report to Council at a Regular Council meeting for releasing items from closed, which included the Oak Trees on Lillooet Avenue West. Council passed a resolution (*RC-2023-10-15*) to receive, among other items, the resolutions *SIC 2023-08-06* and *SIC 2023-08-07* for information.

Later that same meeting, Councillor Allen's requested new business was discussed and the proposed motion was defeated.

At the November 8, 2023 Regular Council meeting, the following took place during "Business Arising From the Minutes":

Mayor Wood recalled the motion from item 14(c) at the October 16 & 18, 2023 Special Council meeting to be voted on again.

THAT staff be instructed to take no further action concerning these four oak trees until Council has had an opportunity to review the arborist report and explore preservation options for them.

Oak Trees on Lillooet June 25, 2024

CARRIED OPPOSED BY COUNCILLORS FACIO AND VIDAL RC-2023-11-04

THAT the arborist report on the four oak trees on Lillooet Avenue West be received so that it can be released to the public.

CARRIED OPPOSED BY COUNCILLORS FACIO AND VIDAL RC-2023-11-05

Staff received two emails dated December 5, 2023 and December 20, 2023 from Mayor Wood ordering that no action be Oak Trees on Lillooet Avenue West until further notice.

At the February 20, 2024 Regular Council Meeting, "Oak Trees on Lillooet Avenue" was added under New Business, resulting in the following resolution being passed:

THAT the four oak trees on Lillooet Avenue be referred back to staff and that all of Council receive details on the legal investigation Councillor Allen referred to.

CARRIED UNANIMOUSLY RC-2024-02-42

On April 12, 2024, staff received a call of concern advising additional large branches had fallen from the oak trees. Council was advised immediately by email of the risk to the public. Councillor Vidal responded stating this is causing a heightened level of concern for public safety and liability to the Village. A motion was passed last summer in a closed meeting to have the trees removed. Mayor Wood disagreed therefore no removal actions were taken. To protect the public and property, staff engaged a contractor to install construction fencing around the trees until Council provides staff with further direction.

DISCUSSION

In their current state, the four oak trees located on Lillooet Avenue, pose a significant risk to public safety. Despite the issue having been discussed by council on multiple occasions, staff has received conflicting direction and require clarification from council. The oak trees in question have been identified with failing health and have become hazardous to pedestrians and nearby properties. Concerns about their stability and potential for failing have been raised repeatedly by residents and council members.

The trees were first assessed for their condition and risk factors by a qualified arborist to determine the best course of action, which included options for removal or intensive maintenance. It was determined that the trees posed a clear danger to public safety due to their deteriorating state. Several solutions were proposed, including immediate removal and replacement with safer species, or intensive rehabilitation measures if deemed feasible.

Despite these initial steps, progress has been hindered by challenges at the council table which has resulted in the matter not being properly addressed. This has prevented the implementation of necessary measures to address the public safety risk posed by the oak trees. The continued presence of these hazardous trees in their current state compromises the safety of pedestrians, motorists, and nearby residents. Potential consequences of inaction include injury, property damage, and disruption to the community.

Oak Trees on Lillooet June 25, 2024

Staff recommends that council urgently revisit the discussion to resolve the issue of the oak trees. Staff recommends re-engaging a qualified arborist to determine the most appropriate course of action based on the current state of the trees.

It is imperative that the council provides further direction to staff on the matter of the oak trees on Lillooet Avenue to prioritize public safety and prevent potential harm.

FINANCIAL CONSIDERATIONS

Subject to Council's direction, expenses for an updated arborist report and, if recommended, tree removal are required.

POLICY CONSIDERATIONS
