QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day Saturday, September 21, 2024;
- resident of British Columbia for at least six (6) months immediately before the day nomination papers are filed; and

- not disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2024 general local by-election, the following expense limits for candidates during the campaign period apply:

Councillor	\$ 5,398.92
